In exercise of the powers conferred by clause (a) of section 9 of the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, 1988 (Central Act 46 of 1988) read with sub-clause (a) of clause (4) of Article 22 of the Constitution of India and in supersession of the notification No.



Home-SSA1/277/2023-Home dated 05th July, 2023 and published as S.R.O.No.748/2023 in the Kerala Gazette Extraordinary No.2242 dated 6th July, 2023, the Government of Kerala in accordance with the recommendations of the Registrar General of the High Court of Kerala hereby reconstitute the Advisory Board, for the purpose of the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, 1988 (Central Act 46 of 1988) consisting of the following persons, namely;

- (1) The Hon'ble Mr.Justice N.Anil Kumar (Retired High Court Judge) Chairman VI/74-A, 'Tulsi' (H), Kannattuthara Road, Behind kainikattu Rice Mill, Kothad P.O, Ernakulam -682027.
- (2) Sri.Mohammad Vaseem (Retired District Judge) Member 1F, Jains Charing Cross, Kaloor -Kadavanthara Road, Kathrikadavu Junction, Ernakulam 682017.
- (3) Advocate P.N.Sukumaran Member Puliammakkil House, South Paravoor P.O, Manakunnam Village, Ernakulam-682307.
 - 2) The Headquarters of the Board will be at Ernakulam.
- 3)The Chairman and members shall not be entitled to any extra remuneration for the above work, but they shall be eligible for travelling allowance and daily allowance as are admissible under the rules regulating the service conditions of Chairman, Members and staff of the Advisory Board of the Kerala Anti Social Activities (Prevention) Act, 2007 (34 of 2007).

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Advisory Board under the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, 1988 (Central Act 46 of 1988) has been constituted as per the notification No. Home-SSA1/277/2023-Home dated 5th July, 2023 and published as SRO No. 748/2023 in the Kerala Gazette Extraordinary No.2242 dated 6th July, 2023 with Hon'ble Mr. Justice A.K.Jayasankaran Nambiar, Judge , High Court of Kerala as Chairman and Hon'ble Mr. Justice Anil K. Narendran and Hon'ble Mrs. Justice Anu Sivaraman, Judges of the High Court of Kerala as its members.

The Registrar General, High Court of Kerala has requested Government to explore the feasibility of constituting the Advisory Board under Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, 1988 (Central Act 46 of 1988), with former Judges of High Court/persons qualified to be appointed as Judges of High Court, in lieu of the present practice of nominating sitting Hon'ble Judges to this Advisory Board.

Government after considering the recommendation of the Registrar General, High Court of Kerala and other factors, have now decided to constitute the Advisory Board with the members of the present Advisory Board constituted under the Kerala Anti Social Activities (Prevention) Act, 2007 (34 of 2007) to streamline the proceedings effectively by the same Advisory Board and for administrative convenience.

The notification is intended to achieve the above object.
